STUDENT DROP-OFF / PICK-UP RULES (INCLUDING PROVINCIAL AND MUNICIPAL BY-LAWS)

The safety of our children and community continues to be a priority at OLPH. Please review the following rules (including Provincial and Municipal By-Laws) that we have identified in order to ensure an efficient, and most importantly safe drop-off and pick-up of our students.

When Driving in School Zone

I UNDERSTAND that all parents, guardians, etc. must:

- **FOLLOW** the 30 km speed zone in effect from 8:00am to 5:00pm on school days.
- **NOT** U-turn.
- **NOT** engage in distracted driving (ie. texting).
- **ONLY** children old enough to safely open/close car doors on their own may be permitted to use the drop off zones.
- **MUST** follow all driving laws as set out by the Ministry of Transportation and Infrastructure (http://www.th.gov.bc.ca/key_initiatives/legislation/mvb-amend.htm).

Parking

I UNDERSTAND that all parents, guardians, etc.:

- are **NOT** allowed to park in the church parking lot.
- are **NOT** allowed to enter/park in the staff parking lot.
- **CANNOT** park within 6 meters from a stop sign.
- **CANNOT** park within 6 meters of a fire hydrant.
- **CANNOT** block the neighbours' driveways and alleyways.
- **MUST** follow all parking rules as set out by City of Vancouver Street and Traffic By-laws (<https://vancouver.ca/streets-transportation/school-zones.aspx>).

STUDENT DROP-OFF / PICK-UP RULES AND PROCEDURES

City of Vancouver Street and Parking By-laws

I UNDERSTAND that all parents, guardians, etc. cannot stop or park at a NO STOPPING zone:



- Effective from 8:00am to 5:00pm on school days
- Zone must be clear of vehicles
- Section 3: Once your vehicle stops moving, it has stopped.
- Section 17.1: You cannot stop in a NO STOPPING zone for any reason, or any length of time

City of Vancouver Traffic and Parking Bylaws (con't)

I UNDERSTAND that all parents cannot park in a NO PARKING zone for more than 5 minutes:



- Effective from 8:00am to 5:00pm on school days
- Section 3: If your vehicle stops, and is not loading or unloading passengers, it is parked, whether it is occupied or not
- Section 17.6A (a): You can stop in a NO PARKING zone for up to five minutes to load or unload passengers, or materials

Respect

I UNDERSTAND that:

- I must conduct myself in an orderly, respectful and courteous manner at all times.
- I will treat all parking volunteers, parents, guardians and community neighbours with kindness and respect.
- Others may be afraid or allergic to pets and I will not bring any pets onto school grounds.
